

### 1. PROJECT INTRODUCTION

East Anglia THREE will be a large offshore wind farm, located 69 km off the Norfolk coast. With a projected capacity of approximately 1400MW, the wind farm shall supply electricity to approximately one million UK homes. Onshore construction for the project started in July 2022, with offshore construction scheduled to commence after main site investigations in 2025.
