1. MARINE ACTIVITIES

1.1. Summary:

Mariners are advised that the vessel **'Seaspan Situla'** will commence monopile installation noise monitoring operations within the East Anglia THREE Offshore windfarm area circa the 30/03/2025. Operations will be conducted by Seaway 7 and Seiche. The main working area will be inside of the CDM Zone of the wind farm array as detailed in section 2.1.

During the monopile installation noise monitoring campaign, all vessels are requested to keep a 500m safety distance from the Seaspan Situla.

1.2. Activity Description:

Seaspan Situla will deploy noise monitoring equipment during installation of the first **six** piled foundations. Noise monitoring will be conducted using a combination of moored monitoring stations and vessel-based deployment. Prior to each pilling event to be monitored, **four** moored stations will be deployed on the seabed in a straight transect at distances of 500-750 metres, 1.5km, 3-6km and 8-15km. Each station will have a mounted hydrophone which will sit approximately 2.5 metres above the seabed. The vessel-based deployed hydrophone will be positioned in the middle of the water column.

Positions of deployed noise monitoring equipment will be notified via future notice to mariners.

1.3. Program Schedule:

- The **'Seaspan Situla'** is expected to mobilise at Den Helder circa the 30/03/2025 and commence operations within the East Anglia THREE CDM zone circa the 01/04/2025.
- During the installation of the first six monopiles, the 'Seaspan Situla' will deploy noise monitoring
 equipment in different locations, these locations will be notified via future notice to mariners as and
 when deployed.
- Completion of the noise monitoring operations will be communicated via a future notice to mariners.


