## 1. MARINE ACTIVITIES

### 1.1. Summary

Please be advised that confirmed Unexploded Ordnance has been identified at the following locations displayed in section **2.1 for Offshore, 2.2 for Export Cable Route & 2.3 for Near Shore.**

In the interim period prior to disposal, all vessels are advised to avoid the item's locations by a **300m** radius from the position highlighted for **EA3 CDM ZONE.**

In the interim period prior to disposal, all vessels are advised to avoid the item's locations by a **350m** radius from the position highlighted for **Near Shore.**

A larger safety distance will be implemented during positive Explosive Ordnance Disposal operations, and this will be **1NM from the Glomar wave & HM Denham.**

Please be advised section **2.4 displays a list of confirmed Unexploded Ordnance that have now been disposed and cleared.**
