1. Transit of Jack Up Barge and associated marine spread from Felixstowe to Worksite off Bawdsey

The following planning applies – **dates are subject to movement due to weather or other considerations;**

- 1.) Planned operations period for transfer of Jack Up Barge from Felixstowe Port to Worksite adjacent to Bawdsey – Works to be carried out within a period from 20/11/18 to 31/01/19
The transits will be entirely dependent on weather and works programme and shall take place at any time (subject to Harwich VTS approval) during the period 20/11/18 – 31/01/19.
During the tow the jack up barge shall display restricted manoeuvrability day shapes.

The works comprise of the following locations.

- Within the Construction Corridor at Works/Pull in Site.
- Navigation Channel & the Port of Harwich and Felixstowe (between vessel mooring location and construction corridor during transit to/from worksite).

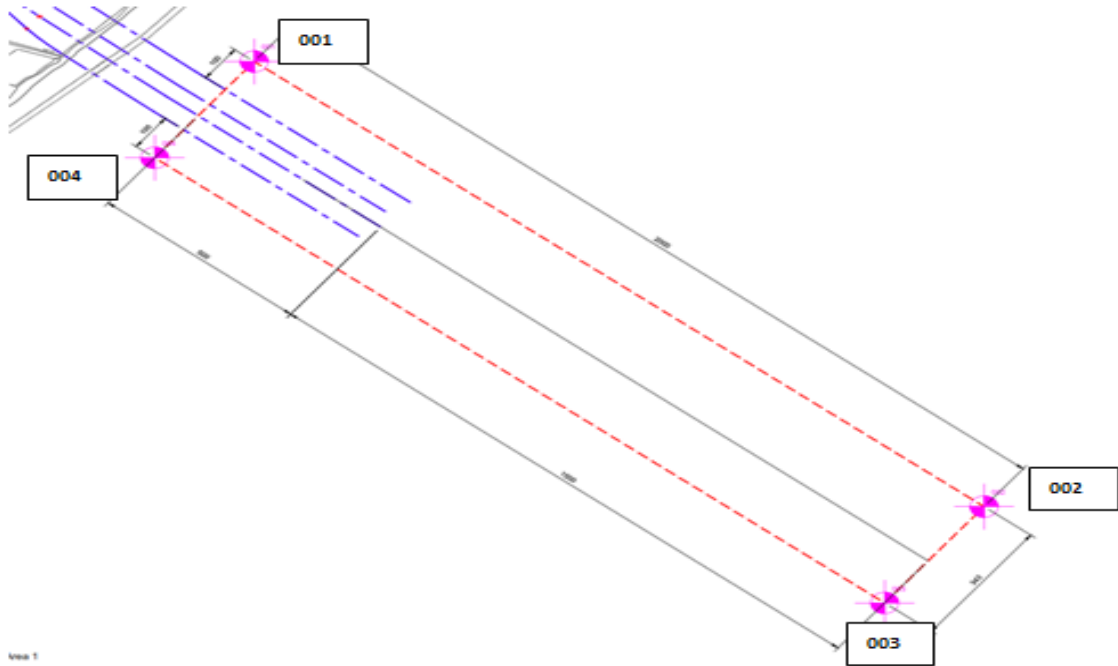
Overview of work locations
